#### SWEEPSTAKES DESCRIPTION:

#### ELIGIBILITY

The Contest is open to legal residents of Canada and the United States where not prohibited by law, who are between the ages of thirteen (13) and eighteen (18) years of age at the time of entry who have Internet access and a valid email account prior to the beginning of the Contest Period. #### SWEEPSTAKES PERIOD

The Sweepstakes Takes place on Tuesday, May 7, 2019 from 4:00pm to 6:00pm ("Sweepstakes Period"). The winner of the tournament will be announced on Wednesday, May 8, 2019 for the grand prize. All entries (submissions) must be received on or before the time stated during that submission period. The Richmond Olympic Oval reserves the right to extend or shorten the contest at their sole discretion.

#### HOW TO ENTER

Entrants must have teams of two (2)s in order to participate in the tournament. Entrants will be deemed to have entered the contest by registering with Richmond Oval Staff at the Richmond Olympic Experience Theatre prior to the round robin play commencing during the Sweepstakes Period.

#### WINNER SELECTION

The Winner will be determined through round robin play of the videogame Overcooked. Timeslots will vary depending on the number of teams participating. One (1) round will consist of a best of three (3) games played. Entrants may repeat the same level for the three games, or choose a different level for every round. Teams will have one (1) minute in between games to strategize, and may not pause the game at anytime. The winning teams from each round will advance until there is only one team remaining and determined the winner by Richmond Olympic Oval staff.

The winner will be announced on Wednesday, May 8, 2019 no later than 5pm PST. Announcement and instructions for the claiming of the "Overcooked" prize package will be sent to the email address supplied on the potential prize winner's entry form. If an email address is not supplied, the Administrator will use the telephone number provided in the entry form. Each entrant is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this sweepstakes. If a potential prize winner cannot be reached by the Administrator (or Sponsor) within fourteen (14) Business Days using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize.
